7. Media Trial: Special Reference to the role of print media in Sheena Bora murder case

Abstract

Violence against women has been increasing day by day and the media reporting of these incidents seems to be flawed and biased. The present study has taken the initiative to look into this issue by studying the media reports on Indrani Mukerjea case alias Pari Bora qualitatively. The aim of the study is to find out whether there is a representation in reporting the news items related to this case in print media. This study analyzed reporting of Indrani Mukerjea case in Four newspapers in month of July 2015 to Nov 2022 period in a comparative manner. The data collected was analyzed using discourse analysis and content analysis. It was found that there are differences in the way of reporting of Indrani Mukerjea case among the newspapers which has been discussed in the paper in a detailed manner.

Introduction

In the year 2012 Indrani Mukerjea was arrested for the murder of Sheena Bora, the shocking news, in this case, was that Sheena was the daughter, not the sister as claimed by Indrani Mukerjea. The media highlighted the case and even after her arrest Indrani never accepted that she had two children and was stuck to her statement claiming Sheena was her sister. The murder also brought into light the murky financial dealings of Indrani Mukerjea and her husband Peter Mukerjea. They successfully manipulated facts hence no trail was initiated against them for three years. The personal life of Indrani Mukerjea had been pierced by the tormenting eyes of the media which paved the way for fresh debate in the murder trial issue of the accused. Indrani's character and personal life, all the aspects which have no ration with the investigation of the murder of Sheena were under the public lens of scrutiny through media. Journalism ethics had been again under controversial debate due to their meddling with the personal


matters of the accused. (Indrani Foiled Family's Attempts to File Missing Complaint for Sheena, 2015)

Indrani Mukerjea alias Pari Bora, wife of former Star India CEO Peter Mukerjea, is behind bars for the murder of her daughter (Dainik Bhaskar, 2019). This high-profile murder case has been the most discussed in 2014-2015. By making it to the Wall Street Journal's list of 50 women, she has been on par with Indira Nooyi. Indrani, who has been the founder and CEO of INX, is a very ambitious woman. Pari Bora from Assam got married for the first time at the age of 18 after falling in love with a boy named Siddharth Das. Both of them had two children, Sheena and Mikhail. After this Indrani married a man named Sanjeev Khanna and had a daughter named Vidhi. After a few years of marriage, Sanjeev and Indrani separated. Later, Star India HR Indrani started dating Peter Mukerjea, who was 16 years older than her. The news of these two dating started becoming headlines on Page 3. Indrani didn't even tell Peter about her children from the first marriage. For the general public, Sheena was Indrani's sister. Meanwhile, Peter Mukerjea's son from his first wife, Rahul came close with Sheena and both wanted to marry each other. Peter and Indrani were against their relationship. In such a situation, news came that an ambitious mother found it appropriate to kill her own daughter for her better future. This high-profile crime is the rarest example of an honor killing by a woman against a woman. Therefore, this research case was chosen to study the role of media in this matter.

Details About the Case

In May 2012, Mumbai Police found a half-burnt body in the Raigad forest. Since it remained unclaimed for months, police performed the last rights of the body. Later, during the trial of another case, driver named Shyam revealed that the body was of Sheena Bora, who was murdered by her mother Indrani Mukerjea. This case of mother getting her daughter murdered remained in the news after as it got linked to the glamor world. (Sheena Bora Murder: "Red Tape" Prevented Rahul from Filing FIR, 2015)

Indrani Mukerjea has been one of the popular media personalities of the country. She
was the second wife of Peter Mukerjea. The same Peter Mukerjea who played a big
role in establishing the Star India channel in the country. Indrani was born in Guwahati,

Assam in the year 1972. Indrani's childhood was not very good. After completing her schooling, Indrani went to Shillong where she met Siddharth Gupta, and both of them got married, after which Mikhail and Sheena were born. But their marriage did not last long and they separated. Indrani left her children with her parents and she moved to Kolkata where she met Sanjeev Khanna, and they got married in 1993. After a few years of marriage, Indrani had a daughter, Vidhi, but after some time they also got separated. In the year 2001, she came to Mumbai from Kolkata, after which she started looking for recruitment in Star India. It was here that he met Peter Mukerjea and the two started dating. After dating each other for a long time, Peter Mukerjea prepared Indrani for marriage. Both of them got married in 2002. This was Peter's second marriage, at the time of marriage he was 46 years old while Indrani was 30. Both of them had no idea about each other's past lives. After marriage, Peter Mukerjea also made Indrani Mukerjea his business partner and both of them started a new company INX in 2007. Indrani also secured a place in the list of 50 Powerful Business Women in 2009. On August 21, 2015, suddenly, the police arrested Shyam Rai, the former driver of Indrani Mukerjea, in connection with a case of possessing weapons. After questioning him extensively, he confessed that Indrani Mukerjea was involved in the murder of Sheena Bora. Subsequently, on August 25, 2015, Indrani Mukerjea was arrested in the Sheena Bora murder case. The CBI identified the badly decomposed body as that of Sheena Bora. (Ex-CEO of TV channel held in murder case. The Hindu. 2015, August 25)

Each unfolding event in this case appeared like scenes from a thriller film. In the course of the investigation, the police also questioned Indrani's husband, Peter Mukerjea, and their son, Rahul. Later, Peter was also arrested. After the murder, Sheena Bora's body was disposed of by pouring petrol on it and setting it on fire in the jungles of Raigad. On September 2, 2015, when Indrani and Peter were confronted face-to-face for questioning, tears rolled down Indrani's eyes upon seeing Peter, and she became emotional. The next day, several truths emerged in the case when a diary belonging to Sheena was found at Indrani's residence in Guwahati. In that diary, Indrani was referred to as a witch. Sheena also expressed her longing for her father Siddharth Gupta, mentioning that he occasionally visited her. Indrani Mukerjea's new statement created a sensation, as she confessed that Sheena Bora was not her sister but her daughter. News related to women are presented as sensational by news channels, for the sake of fastest breaking news and exclusive coverage, they show no restraint. Instead of delving into the mystery of Sheena's murder, the media seems to be engaged in extracting various angles in a triangular manner. Rather than going into the depth of the truth, news channels ran news trials, openly scrutinizing both the accused and witnesses. Even after several years since the Sheena Bora murder, the case continued to be shrouded in mystery, creating a sensation throughout the country. The CBI has also investigated this high-profile murder case, but many questions related to this case remain unanswered, and the accused have been released on bail. It is a murder mystery where the secrets have not been unveiled to this day, and the veil over the enigma remains untouched. Research Methodology

This is analytical research.

Sample size and duration

The data was collected by analyzing the news reported in the print media for a period from July 2015 to January 2023. The reports of Indrani Mukherjee case were included in the study. The news in two leading Hindi dailies national newspapers and two English Dailies national newspapers were selected.

These Four newspapers were used in this study -

1. Dainik Bhaskar: 4.5 million


2. Dainik Jagran: 3.6 million

3. The Hindu: 1.4 million

4. Indian Express: 1.6 million

Procedure and research design

- 1. The study was conducted using discourse analysis and content analysis as it is most suitable for the study of media.
- 2. Content Analysis is used in order to have an objective understanding about the reporting of Sheena bora murder case.

3. Discourse analysis is used in order to have a deeper understanding about the titles of newspaper reports. The paper reports are exhaustively analyzed, verbatim and words that are used to sensationalize the report were identified.

Content Analysis

It is one of the methods used in summarizing any form of content only after having a deep study of the actual content. This enables the researcher to more objectively evaluate and understand the situations. Content analysis, tries to analyze written words. The results of content analysis are in numbers. It starts with the process of selecting content for analysis, and then preparing the content for counting and weighing.

The content analysis therefore serves two basic purposes:

- 1. It helps in removing much of the subjectivity from summaries. It also helps in the detection of trends in an easier and simpler manner.
- 2. Intra-media Analyses- This type of study analyses the content within individual newspapers. It is primarily focused on initial exploratory studies on the four individual newspapers selected for this research. For intra- media analysis, exhaustive study of all the four Newspapers during the period of July 2015 to January 2023 was analyzed. The study is focused on four different aspects of the News.

Analysis and Interpretation

Analysis of News Articles published in Dainik Bhaskar Newspaper related to Sheena Bora case

Researcher analyzed the news coverage of the Dainik Bhaskar's Bhopal edition from a research perspective. Thirteen news articles were published, prominently featured on the main page with accompanying photos. All the news articles were highlighted on the main page, and none of them included editorial or headline coverage. A detailed description of these articles is provided in Crime Table 1.

Content

Dainik Bhaskar did not run any campaign to seek justice for the victim; however, news related to the incident was covered on the main page with photos. Alongside publishing news, Dainik Bhaskar also gave adequate follow-up coverage to this incident. Some news articles were published in a way that went beyond the case, delving into the accused's personal life and the world of glamour.

Language Used

In the published news articles of Dainik Bhaskar related to the Sheena Bora case, there was no in-depth investigation into the reasons behind the murder. Balanced language wasn't used, and content had lack of sensitivity. The language used resembled the sensational language of television channels in reporting on a woman's crime usually used to increase TRP.

Figures

Analysing the news articles related to the Sheena Bora case published in Dainik Bhaskar, the researcher found that 13 news articles were prominently featured on the main page, each accompanied by a photo. All the news articles were published on the main page. Editorial and headline coverage was missing in these articles.

Role in Creating Public Awareness

By analysing all the news articles of Dainik Bhaskar, it seems that at the time of publication, an attempt was made to give momentum to the victim's voice. In the initial days of the case, the news publication did not give any special attention to the case, but after the discovery of the victim's body, media coverage took a more responsible approach to seek justice.

Content

The Hindu did not run any campaign to seek justice for the victim, but news related to the incident was covered on the main page along with India and cities pages with photos. The Hindu also provided sufficient follow-up coverage to this incident.

Language Used

In the published news articles of The Hindu related to the Sheena Bora case, there was no indepth investigation into the reasons behind the murder. Balanced language was used, and language was sensitive in the articles.

Figures

Analysing the news articles related to the Sheena Bora case published in The Hindu, the researcher found that 23 news articles were prominently featured on different pages including main page, each accompanied by a photo. None of the articles included editorial or headline coverage.

Role in Creating Public Awareness

Through the analysis of all the news articles of The Hindu, it seems that at the time of publication, an attempt was made to provide information and updates on this incident to the public. The Hindu played a significant role in advocating for justice for the victim in the reporting of the entire incident.



Researcher analyzed The Indian Express's news coverage from a research perspective. Of the published 15 news articles, 6 were featured on the city page with photos related to the incident. The remaining articles were published on other pages, including the main page. None of these articles included editorial or headline coverage. Content

The Indian Express didn't ran any campaign to seek justice for the victim, but news related to the incident was covered in its articles with photos. However, The Indian Express did not give sufficient prominence to the follow-up coverage of this incident.

Language Used

In the published news articles of The Indian Express related to the Sheena Bora case, there was an in-depth investigation into the reasons behind the murder. Articles used a balanced language, and there was a display of sensitivity in tone used for writing the articles.

Figures

Analyzing the news articles related to the Sheena Bora case published in The Indian Express, researcher found that 6 news articles were featured on the city page, each accompanied by a photo. The other articles were published on other pages, including the main page. None of the articles included editorial or headline coverage.

Role in Creating Public Awareness

Through the analysis of all the news articles of The Indian Express, it seems that at the time of publication, an attempt was made to provide information and updates on this incident to the public. The Indian Express played a significant role in advocating for justice for the victim in reporting the entire incident.

Upon examining the subject matter of this case, the researcher found that whether in Hindi or English newspapers, no organization raised any serious questions about this case in its initial days. The case drew the attention of the media only when prominent names started getting involved. Therefore, the researcher concluded that the media stakeholder were more interested in taking Indrani behind bars rather than actually getting justice for the victim.

Language Used


The language level in this case remained average. While the language in some news articles of Dainik Bhaskar appeared sensitive in Hindi, in some instances, it resembled Bollywood sensational news. On the other hand, English newspapers, particularly The Hindu, demonstrated a more sensitive language. Both newspapers provided a balanced presentation of language in their respective coverage.

Figures

Analyzing the news published in Dainik Bhaskar, the researcher found that out of the 13 published news articles, all were featured on the main page as news, along with accompanying photos. Similarly, Jagran published 7 news articles, all on the main page, in the form of news, accompanied by photos. In English newspapers, The Hindu published 26 news articles, most on its front page, in the form of news, accompanied by 26 photos, which were published in all editions in Madhya Pradesh. In comparison, Indian Express published 15 news articles, of which 6 were published on the city page as news, accompanied by photos. The remaining articles were published with prominence on other pages in India and other sections.

Role in Creating Public Awareness

No newspaper played a significant role in creating a public protest in this case. The main reason for this is that in its initial days, this incident was not even a news item for the media. This is the primary reason that no public movement took place to seek justice for the victim in this case.

Conclusion

Researcher here concludes the research using following points:-

Sensitivity in Language- Media coverage in this case only gained traction two years after the victim went missing, primarily because prominent names became associated with the case following the discovery of the victim's body. There is skepticism about whether the media would have covered the Sheena Bora murder case if the accused were not wealthy and famous. Consequently, the language used by the media in this case was not driven by a sense of empathy or a commitment to justice for the victim. Instead, it appeared to be more of a sensationalized news story, given the involvement of a notable personality in a crime.



However, after the names of riches came along media gave subsequent attention to the case which in turn created pressure on police and they worked hard to dig deep into the case to provide justice to the victim.

Effect of case- This case may not have a significant impact on Indian criminal law or the functioning of the judiciary. But, it had a profound impact on Indian society at a social level. The shocking nature of the crime, involving a mother's involvement in her daughter's murder, challenged preconceived notions within Indian society. It shattered traditional beliefs, as such heinous acts were not previously thought possible within familial structures.
